FOR EMPLOYEE APPLICANTS OVER AGE 18

This is "seasonal, at will" employment. You are free to terminate your employment with the Orange County Council (OCC) at any time, with or without reason, and the OCC has the right to terminate your employment at any time, with or without reason. Although the OCC may choose to terminate employment for cause, cause is not required. This is called "at will" employment.

All offers of employment are contingent on verification of your right to work in the United States. Before your first day of work you will be asked to provide original documents verifying your right to work and to sign verification forms required by federal law. If you, at anytime, cannot verify your right to work in the United States, the OCC may be obliged to terminate your employment.

FOR VOLUNTEERS AND APPLICANTS UNDER AGE 18

As a staff volunteer, your participation in this program is strictly voluntary and only permitted with the approval of your parent or guardian. Although volunteers receive certain benefits similar to employees, you are not an employee of the Orange County Council or its staff. With such approval, as a person under the age of 18, the extent of your participation is limited by law as to hours of participation, and such limitations are to be followed at all times.

Your participation in the camp staff experience is also seasonal and at will. You are free to terminate your participation in the program by notifying your supervisor or the Orange County Council at any time, with or without reason, and the Orange County Council may likewise terminate your volunteer privileges at any time, with or without reason. Although your participation may also be terminated for cause, cause is not necessary for such termination. This is the basis of the "at will" status of your participation.
