In keeping with current Boy Scouts of America policy, any group using Schoepe Scout Reservation at Lost Valley will have at **least two leaders present at all times** (One of which must be registered with BSA – *BSA units only* – and at least 21 years of age).***BSA Units must bring their approved Tour Permit and Roster to Camp*** The Property Manager may make changes in facility use assignments to better accommodate the use of the facility for all campers and as other needs arise such as maintenance. *During council sponsored activities, the camp will provide CPR & first aid trained personnel, qualified by a nationally recognized organization to render medical assistance. During non-council sponsored activities units/groups should provide their own CPR, supplies and first aid trained personnel qualified by a nationally recognized organization. If an injury occurs and is life threatening, a Life Flight helicopter ambulance will be called into camp. If an injury occurs and is not life threatening, the unit/group will be responsible for providing transportation to the nearest medical facility. During council activities, the camp will provide medical supplies. All injuries occurring in camp should be documented and reported to the camp medical officer or camp ranger staff.*

Unit insurance is required for attendance at camp. All units from outside the Orange County Council must indicate their unit insurance program. (Non-BSA Groups must provide \$1 million liability certificate and sign a hold-harmless agreement.)

NOTE: All reservations must be made **at least two weeks in advance; programs require 3-4 week advance notice and are subject to staff availability.** The fees must be paid when making your reservations or a minimum deposit of 50% of expected use fees. The balance is due at least two weeks prior to camping trip (current fees listed below). Regardless of the actual final number of participants, the unit is responsible for at least 80% of the reservation. If your trip is canceled, **written notice of your cancellation** must be received **at least two weeks prior to the camping reservation date** and all refunds are subject to a 15% cancellation fee. **No refunds are given for "no-shows."** Groups must haul out their own trash. **All BSA groups must bring an approved tour permit to camp.**

2007 SCHOEPE SCOUT RESERVATION USE FEES CAMPING FOR SCOUT GROUPS

CAMPING:

Scout unit's camp use fee is \$10.00 per person. This covers use of camp and access to restrooms and water. (Both are nearby if not in campsite.)

BUILDING USE: All building deposits are due at camp. **All Building Fees are in addition to your camping and program fees.**

- Log Cabins: \$80.00 (includes heat and electrical); Eight (8) Bunks.
\$30.00 per cabin cleaning deposit. (Cabin fee is in addition to camp use fee.)
- Beckman Hall Conference Facilities Only: \$175 + \$300 cleaning deposit.

PROGRAM FEES:

- Archery Range: \$2.00 per person + charge for lost arrows
- Rifle Range: \$2.00 per person + \$1.00/10 shots. (Ammunition charges paid at camp.)
- Shotgun Range: \$2.00 per person + \$1.50/5 shots. (Ammunition charges paid at camp.)
- BB Gun Range: \$1.00 per person.
- COPE: \$25.00 per person **Minimum charge - \$125** (Age minimum of 13 yrs old)
- Rock Climbing/Rappelling: \$25.00 per person **Minimum charge - \$125** (Grade minimum – 5th grade)
- Observatory: No charge
- Conservation/Service Projects: No charge
- Food Service (4 Meals): \$30.00 per person (**must be pre-arranged**)

(Flat Fees are available for large groups.)

All camp provided meals are prepared and served ONLY in Beckman Dining Hall. There shall be no exclusive use of Beckman Hall during meal times. The climbing wall shall be available at all times. The Camping Director, Property Manager and Chairman of the Lost Valley Committee must agree in writing to any exceptions of this policy.

2007 SCHOEPE SCOUT RESERVATION USE FEES FOR NON SCOUTING GROUPS/CLUBS

INSURANCE:

Groups must provide \$1 million liability certificate and sign a hold-harmless agreement.

CAMPING:

Non-Scouting unit's camp use fee is \$12.00 per person. This covers use of camp and access to restrooms and water. (Both are nearby if not in campsite.)

BUILDING USE: All building deposits are due at camp. **All Building Fees are in addition to your camping and program fees.**

- Log Cabins: \$100.00 (includes heat and electrical); Eight (8) Bunks.
\$30.00 per cabin cleaning deposit.
- Beckman Hall Conference Facilities Only: \$200 + \$300 cleaning deposit.

PROGRAM FEES:

- Archery Range: \$3.00 per person + charge for lost arrows
- Rifle Range: \$3.00 per person + \$.75/10 shots. (Ammunition charges paid at camp.)
- Shotgun Range: \$3.00 per person + \$1.50/5 shots. (Ammunition charges paid at camp.)
- BB Gun Range: \$2.00 per person.
- COPE: \$30.00 per person **Minimum charge - \$150.00** (Age minimum of 13 yrs old)
- Rock Climbing/Rappelling: \$30.00 per person **Minimum charge - \$150.00** (Grade minimum – 5th grade)
- Observatory: No charge
- Conservation/Service Projects: No charge
- Food Service (4 Meals): \$35.00 per person (**must be pre-arranged**)

(Flat Fees are available for large groups depending on area.)

All camp provided meals are prepared and served ONLY in Beckman Dining Hall. There shall be no exclusive use of Beckman Hall during meal times. The climbing wall shall be available at all times. The Camping Director, Property Manager and Chairman of the Lost Valley Committee must agree in writing to any exceptions of this policy.
